\* Ms Bouchahboune was disqualified from remaining as a Parent Governor as she was employed at the school from 6 January 2021. The Governing Body appointed her as an Associate Member with effect from 6 January 2021. Ms Bouchahboune is a member of the Curriculum and Pastoral Committees, and has voting rights on those committees.

The Governing Body meet termly. Governors reviewed their Committee structure in November 2020; there are four Committees. The Governing Body agree Terms of Reference for the Committees each year, in the autumn Term. Due to the COVID-19 restrictions, all Governing Body meetings in the 2020-2021 academic year were conducted remotely.

Governors are required to publish their attendance at full Governing Body meetings and Committee meetings for the last academic year. This requirement also applies to Governors who have stepped down (or completed their four year term) in the last twelve months. Governors no longer in post are listed at the bottom of the table below.
